Central University of Rajasthan has decided to sell / dispose off its condemned vehicle **Mahindra Scorpio** through the public auction **on 10<sup>th</sup> May 2017 at 11 AM** Venue- Auditorium of Central University of Rajasthan as per following terms and conditions:-

1. The vehicle will be sold on "As is where is basis". The auction process will be conducted by auction committee of this University. Taxes and duties that may be levied by Government will be extra as applicable.
2. The bidder may inspect the said vehicle from 02<sup>nd</sup> May 2018 to 09<sup>th</sup> May 2018 on working days from 10.00AM to 4.00PM. and may contact the Transport Section **(Ph.No.01463-238589)**
3. Every intending bidder will have to register themselves by way of depositing Rs. 500/- in cash (Non-refundable) and EMD of Rs. 5,000/- in the form of Demand Draft in favour of Central University of Rajasthan, at least 30 minutes before the scheduled time of auction.
4. The Demand Draft deposited as EMD will be returned to the unsuccessful bidders on the spot by the University auction committee.
5. The successful bidder shall have to deposit 25% payment against their bid as soon as the bid is over. In case of failure to deposit the 25% amount after adjusting the EMD on the spot, the EMD of Rs. 5,000/- will be forfeited. If highest bidder does not accept the offer of sale of vehicle for any reason whatsoever it may be, and withdraws from the bidding, the second highest bid amount may be considered for sale, if accepted by Hon'ble Vice Chancellor, Central University of Rajasthan and accordingly the second highest bid amount will be considered as

the highest bid amount or respective vehicle may once again taken up for re-auction on the same day.

6. The vehicle will be delivered only after the receipt of full payment and has to be lifted within 07 days of completion of deal failing which ground rent at the rate of Rs.200/- per day will be charged.
7. The person authorized by bidder will be allowed to take the delivery. The bidders are required to produce any of documents as documentary evidence for proof of their address.
8. The University will not owe any responsibility for transfer of vehicle and for any other liability for using this vehicle for commercial or any other purpose after sale.
9. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.
10. The highest bid once accepted is not transferable to anyone. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the auction after submission of the bid will not be entertained.
11. The decision of the auction committee for all the purpose shall be final and binding.
12. The Hon'ble Vice Chancellor, Central University of Rajasthan reserves the right to withdraw the said vehicle(s) from the auction without assigning any reasons thereof.
