

## Draft Committee report on Tender for Hostel Furniture

A Committee consisting of undersigned members was constituted vide Office Order No. CURAJ/S&P/Office Order/2016-17/ 742 dated 01.06.2016 to finalise the requirement alongwith technical specification, design etc. of the furniture.

As per the resolution of the 69<sup>th</sup> Purchase Committee dated 12.07.2016 (item no 69-4.4), this Committee was asked to evaluate the bids and sample of material of furniture. The tender was floated vide tender notice no CURAJ/Furniture/ 2016-17/4401 dated 06.03.2017. The Technical bids of the tender were opened on 19.04.2017.

Accordingly, the committee members transected its business in various sittings, rounds of discussion, and physical verification of samples. The comparative Technical Bid Evaluation Statement is as under:

#### Committee Observations:

- The Committee observed that M/s Banthiya has submitted similar experience documents of only two works valuing more than 27 lacs in last 5 years instead of three works.
- Two bidders i.e M/s Saviton Living Concepts, New Delhi and M/s Delite Hi-Tech Furniture Industries Pvt. Ltd., New Delhi has not submitted documents conforming factory set up.
- As regards sample submission, Amardeep, Daniel and Delite has submitted the sample material. M/s Saviton has submitted the drawings of all material however the drawings of hostel bed is not as per tender specifications. M/s Banthiya & Co. (p) Ltd., Ajmer has given written information that material supplied in 2013 may be considered as sample (except Mattress for which sample provided). Rest bidders i.e M/s Metalex Office System Pvt. Ltd., Haryana has submitted the photographs.
- The Committee physically checked the sample of furniture supplied by the vendors, details of sample checked is as under:
  - The sample of Almirah, Chair and table provided by M/s Amardeep Designs India(p) Limited, Jaipur was found to be as per tender specifications. However the sample of Bed found with three nos supports of square tube 19 x 1.25 mm thick instead of five nos. below 1.25 mm thick sheet.
  - The sample of Almirah, Chair and table provided by M/s Daniel Furnitures (P) Limited, Jodhpur was found to be as per tender specifications. However, the sample of Hostel Bed is without two center legs.
  - The sample of Bed, Chair and table provided by M/s Delite Kom Limited, New Delhi was found to be as per tender specifications.

5. M/s Saviton Living Concepts, New Delhi and M/s Delite Hi-Tech Furniture Industries Pvt. Ltd., New Delhi have submitted the EMD for all 5 items. M/s Daniel Furnitures (P) Limited, Jodhpur is exempted for EMD as the firm is enlisted in NSIC. M/s Metalex Office System Pvt. Ltd., Haryana has not submitted the EMD for Almirah and Mattress. M/s Delite Kom Limited, New Delhi has not submitted the EMD for Mattress, M/s Banthiya & Co. (p) Ltd., Ajmer has not submitted the EMD for Almirah and M/s Amardeep Designs India(p) Limited, Jaipur has not submitted the EMD for Mattress.
6. The Committee also observed that the tender was floated before implementation of GST i.e 01.07.2017. As such the implications of GST on the quoted rates may vary.

**Committee Recommendations:**

1. The committee recommends that the following bidders with under mentioned items are technically qualified for opening of financial bids:
