Sealed Tenders should be dropped in tender box in the office of the Registrar on or before 2.00 PM, 06.07.2017 along with Earnest money amounting shown in table-I, in form of D.D., in favour of Central University of Rajasthan and copy of the certificates. Date and timings of opening of the Tender is 06.07.2017 at 3.00 PM. Tenders will be opened in the Administrative building, Central University of Rajasthan, Bandarsindri, Kishangarh.

#### **Terms and Conditions of contract**

The prescribed tender documents should be submitted in one sealed envelope duly super scribed with Annual Rate Contract for Supply of water through tractor with tanker/ truck mounted tanker in Central University of Rajasthan Campus. This sealed envelope should contain 2 sealed envelopes marked A and B as prescribed as under:

- a) Envelop A containing the Technical Bid along with all the supporting documents such as tender form fee of Rs.1000/- if applicable and Earnest Money shown in table table-I in the form of Demand Draft in favour of CENTRAL UNIVERSITY OF RAJASTHAN payable at Bandarsindri/ Kishangarh. Tender shall be rejected if the tender form fee and Earnest money D.D.'s are not found in proper order.
- b) **Envelop B** containing the Financial Bid.
- 1. The attested copies of the following documents must be submitted by the tenderer along with tender document:
  - a) Permanent Account Number of the Firm.
  - b) List of major works of similar nature having completed satisfactorily during last two years ending 31.03.2017 with supporting documents.
- 2. Earnest money shown in table-I, in the form of D.D. in favour of Central University of Rajasthan should be enclosed with tender document. Tenders submitted without earnest money will not be entertained
- 3. Sealed tenders should be dropped in the locked tender box placed in the office of the Registrar, Central University of Rajasthan up to 2.00 PM on 06.07.2017. Tenders received after the due date and time will not be entertained.
- 4. Sealed tenders will be opened in the Administrative building at 3.00 PM on 06.07.2017 in the presence of the bidders or their authorized representatives, those who remain present at the time of opening.
- 5. Conditional tenders will not be considered.
- 6. The tenderers are advised to first inspect the site of work and fully understand very carefully about the conditions/ nature of site before submitting tender.
- 7. The work shall have to be started within seven days from the date of issue of work order. In case, the work is not started with in above period, the earnest money shall be forfeited.
- 8. If the work is not found to be satisfactory, the University reserves the right to get the work done from another agency / contractor at the risk & cost of the contractor.
- 9. The Contractor shall adopt all safety measures, which are essential for the execution of the work. The University shall not be responsible for any mis-happening, if occurred while executing the work.

The contractor is advised to have the insurance of his staff / workers and machinery against any mishappening while executing the work at his own level.

- 10. The Central University of Rajasthan reserves all rights to divide the work and accept or reject any or all the tenders without assigning any reason.
- 11. The quantities of the items mentioned in the Schedule can be increased or decreased depending on the prevailing site conditions and requirement.
- 12. The quoted rate shall be inclusive of all taxes and charges as applicable.
- 13. The attested copy of valid registration of tractor and tankers should be submitted along with the bid.
- 14. Tractor tanker/ truck mounted tanker should be equipped with pump to lift water and jet spray to shoot water up to 10 feet long. The firm/contractor will be solely responsible for P.O.L./repairs / maintenance etc. and will provide the required manpower consisting of driver to each tractor tanker. The tractor should have no liability of taxes/police enquiry.
- 15. The rates quoted shall be valid for a period of 12 months from the date of acceptance of the tender and no increase will be allowed during the said period on account of increase in of P.O.L/wages or whatsoever reason.
- 16. The firms/contractors quoting their rates for the supply of tractor, tanker/ truck mounted tanker are required to quote flat rate per trip basis at any location in the University campus.
- 17. The tractor tanker/ truck operators are required to report at designated place as intimated by the office on daily basis as required.
- 18. The tractor / tankers/ truck operators are required to get the trip entered in register kept at the University gate with guards or by any other procedure as decided by the University and be counted towards the work performed.
- 19. University reserves the right to distribute the work among the firms/contractors willing to supply the same as per the rates quoted by L-1 bidder.
- 20. The Central University of Rajasthan reserves the right to accept/reject any bid without assigning any reason.
- 21. Attested copy of original documents i.e. valid registration of firm/contractor/tractor/ truck/ tanker may also be attached with the tender forms. However, original documents will be required for verification at the time of issue of work order.
- 22. The drivers engaged should have heavy duty vehicle license and photo copy of the same should be submitted before issue of work order.
- 23. The tractor/ truck and tanker should have valid insurance policy and the policy should be live during the period of contract for any liability arising during the period of contract.

- 24. The firm/contractors quoting their tenders will give an Affidavit that the firm/contractor has not been blacklisted by any Govt. / semi-Govt./ Board/ Corporation. In case the same is proved during the period of contract, the security deposit will be forfeited and will be debarred from taking any contract with the Central University of Rajasthan.
- 25. Any loss/ damage/ theft caused to the public property/ Central University of Rajasthan/ Residents by the vehicles/manpower engaged shall be sole responsibility of the contractor.
- 26. Any liability arising out of the tractor tanker/ truck tanker/manpower etc. under the provisions of any Act i.e. Motor Vehicle Act, Labour Act, or any other Act as applicable will be the sole liability of the firm/contractor.
- 27. The tractor tanker/ truck mounted tanker should be in good condition such that there should not be any dripping/ leakages in water tanker.
- 28. Penalty clause: The firm/contractor to whom the contract is awarded is required to make 100% availability on daily basis as required. Failing which penalty @ Rs. 1,000/- per day will be levied.
- 29. The Quality of water supplied for item no. 3 of Schedule should be potable water, which could be tested by the University, failing of the desired water quality, University reserves the right to reject the water tanker for payment.
- 30. The successful bidder within fifteen days of the acceptance of the work award shall execute a Performance Guarantee in the form of Demand Draft or Bank Guarantee of any nationalized/scheduled bank, a sum equivalent to 5% of the contract value in favour of Central University of Rajasthan, Bandarsindri / Kishangarh, payable at Bandarsindri / Kishangarh. The Performance Bank Guarantee shall remain in force beyond two months the period of the Contract.
- 31. In case of continuous non-supply of desirable quality water/ tractor/ truck and tankers for a period of more than 7 days, the contract will be terminated and security amount will be forfeited and firm/contractor can be blacklisted
- 32. Payment terms: Payment will be released on monthly basis on production of pre-receipted bill and duly verified by the officer authorized by the University.
- 33. The University reserves the right to terminate the contract at any stage without assigning any reason and reference to the volume of work. However the contractor can terminate the contract by giving at least one month prior notice.
- 34. The Contract on mutual consent can be further extended for a period of up to one year based on the satisfactory performance of the contractor.

#### 35. GOVERNING LAWS AND SETTLEMENT OF DISPUTE

35.1 Any claims, disputes and or differences (including a dispute regarding the existence, validity or termination of this Contract) arising out of, or relating to this contract including interpretation of its terms shall be resolved through joint discussion of the Authorized Representatives of the concerned parties. However, if the disputes are not resolved by the discussions as aforesaid within a period 30 days, then the matter will be referred for adjudication to the arbitration of a sole arbitrator to be appointed by the Client in accordance with the provisions of the Arbitration

and	future	enactments	thereto.	The	venue	for	the	Arbitration	will	be	District	Ajmer	and	the
decision of the arbitrator shall be final and binding on the parties.														

35.2 Jurisdiction of Court: This Contract is governed by the laws of Republic of India and shall be subject to the exclusive jurisdiction of the courts in Jaipur.
