I) dated 24.08.2021 and UGC letter No. F.1-11/2021 (SCT) dated 02.09.2021 regarding filling of vacant backlog positions of SC, ST, OBC and EWS categories in a mission mode within a period of one year starting from 05.09.2021 to 04.09.2022 and to report the action taken in each Finance Committee and Executive Council.</p> <p>In compliance to the above letters, University issued Rolling Advertisement No. 1196 dated 10.09.2021 to fill 13 backlog teaching positions through Special Recruitment Drive for SC, ST, OBC, PWD and EWS categories (Annexure-B – Page No. 23 to 32).</p> <p>This is to further inform that the University has advertised total 64 positions through 04 Rolling Advertisements for various faculty positions and out of total 64 positions, 38 positions are under backlog category.</p> <p>Hence, the Rolling Advertisement No. 1196 dated 10.09.2021 to fill 13 backlog teaching positions through Special Recruitment Drive for SC, ST, OBC, PWD and EWS categories, is placed before the Executive Council for information and ratification.</p> <p>This is further to report that presently, the University does not have the regular Vice Chancellor, as such, appointment on backlog positions could not be made as per MoE (Erstwhile MHRD) letter F.No.-19 -58/2014-Desk(U) dated 09.10.2014 (Annexure-C– Page No. 33) and F.No.52-4/2019-Cu.III dated 06.03.2020 (Annexure-D– Page No. 34 to 35).</p> <p>Placed before the Executive Council for information and ratification.</p> <p>Resolution: The action taken was noted, ratified and approved. During deliberations, it was confirmed that the Advertisements were issued as per the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Amendment Regulations, 2021.</p> <p>It was decided that the Vice Chancellor (I/c) may constitute Committees for initial screening of applications as per UGC Regulations. However, further process like Constitution of Selection Committees and its meetings should be taken up only when the Regular Vice Chancellor joins the University.</p>																
45-4.2	<p>Admission Process for Academic Session 2021-22</p> <p>The university has proceeded with the Admission Process through CCMT, DBT and CUCET. The matter regarding the Admission Process was placed before the Academic Council in its 23rd Meeting held on 15th June 2021 which authorized the Chairperson, Admission Committee / Vice Chancellor to approve the modalities of the Admission Process as proposed by the Central Admission Committee. Accordingly, the modalities for Admission Counselling were prepared by the Central Admission Committee and approved by the Vice Chancellor which were</p>

This included the non-refundable fee for participation in the Admission Counselling Process of Rs. 1000.00 as was being charged in the earlier years.</p> <p>The matter is placed before the Executive Council for information and ratification.</p> <p>Resolution: The action taken was noted, ratified and approved. 45-5.5	<p>Advertisement No. 5413 dated 16.03.2020 for the recruitment of 49 Non-Teaching Positions</p> <p>The University advertised 49 Non-Teaching positions vide its Advertisement No. 5413 dated 16.03.2020. Due to unavoidable circumstances, the final selection process (except one lady doctor) could not be materialized within the validity period of the advertisement.</p> <p>This matter was placed before the Executive Council in its 39th Meeting held on 11.12.2020 and EC approved the extension of the validity of the advertisement for a further period of 6 months <i>i.e.</i> upto 15.06.2021.</p> <p>Further, the matter was again placed before the Executive Council in its 43rd Meeting held on June 11, 2021 and the validity period of the Advertisement no. 5413 dated 16.03.2020 was approved to be extended by another six months <i>i.e.</i> up to 15.12.2021.</p> <p>The extension of the validity period of this Advertisement, as approved by the Executive Council, is going to expire on 15th December 2021.</p> <p>As per CRR-2018:</p> <p><i>“The entire recruitment process including and starting from advertisement, conducting skill/trade test, written test or holding of interview (wherever applicable), etc., may be completed within six months from the date of issue of advertisement.</i></p> <p><i>Where the Selection Committee has not met even after a lapse of 06 months w.e.f. the closing date of application for any post, the post shall ordinarily be re-advertised. In its meeting held on 09.04.2021, two members – Prof. J. K. Prajapat and Dr. M. Vijaya Kumar were not agreeable to the idea of any further process by the Committee in absence of the regular Vice Chancellor. The Committee resolved to meet again but this meeting could not be held as the Chairman of the Committee – The Registrar (Regular) also left the University on 15th July 2021 to join Central University of Sikkim.</p> <p>This is also to inform the Executive Council that one candidate “Mr. Hukma Ram” has filed a Writ Petition in the Hon’ble High Court Rajasthan Bench Jaipur with a request to release the pending results of the recruitment process completed against this advertisement.</p> <p>The appointment status of the Regular Vice-Chancellor of the University is not yet available.</p> <p>Placed before the Executive Council for consideration and further directions.</p> <p>Resolution: During discussions on the matter, it was confirmed that the in-charge Vice Chancellor cannot take a decision for regular appointments as per the MoE directions. 45-5.6	<p>Matter of Relieving of Prof. Ram Lakhan Meena from the Post of Professor at Central University of Rajasthan</p> <p>As resolved by the Executive Council in its 24th Meeting held on 10.08.2016, Prof. Ram Lakhan Meena was not confirmed in the post of Professor at Central University of Rajasthan, his Probation Period was not extended and he was relieved with immediate effect <i>i.e.</i> 10.08.2016 (A/N) (Annexure-G – Page No. 63 to 66).</p> <p>Satyawati College (University of Delhi) vide its letter SC/Admn/549/2015 dated 12.10.2015 had communicated that the lien in respect of Prof. Meena was extended for another period of one year with effect from 14.08.2015 (<i>i.e.</i> upto 13.08.2016) as an exceptional case (Annexure-H-Page No. 67 to 70).</p> <p>Prof. Ram Lakhan Meena has filed a Civil Writ Petition No. 11398/2016 in the Hon’ble High Court of Rajasthan, Jaipur Bench and the decision on the same is pending. The case hearing was listed on 21.09.2021.</p> <p>The University received a letter dated 10.08.2021 from Ministry of Education asking for comments in the matter (Annexure-I – Page No. 71 to 78). In response to this letter, the University submitted its reply dated 18.08.2021 (Annexure-J – Page No. 79 to 106).</p> <p>The Ministry of Education, vide its letter dated 14.10.2021 (Annexure-K – Page No. 107) has requested the University to reconsider Dr. Ram Lakhan Meena’s case. It states as under:</p> <p style="padding-left: 40px;"><i>“Dr. Ram Lakhan Meena, Prof., Deptt. of Hindi, CU Rajasthan was relieved from the University without confirmation of his Professorship and by that time his lien ended at his parent University i.e. Delhi University rendering him jobless. He has already completed 18 years of service in DU and now without any job. It may be noted that the deputation upto 10 years is allowed as per the instructions issued vide this Ministry’s OM dated 13th October 2014 regarding mobility of faculty and non-faculty personnel to the newly established Central Educational Institutions (CEIs). It is, therefore, requested that you may re-consider Dr. Ram Lakhan Meena’s case and take a decision in the matter.”</i></p> <p>In view of this, the matter is placed before the Executive Council for information and further directions in the matter.</p> <p>Resolution: The matter was deliberated. Prof. J. S. Rajput observed that the case is subjective, complex, and has far reaching implications; as such, ideally, it should not have been placed by the In-charge Vice Chancellor before the Executive Council. After brief discussions on the letter dated 14.10.2021 of the MoE, it was decided that the same</p>

		must be placed before the regular Vice Chancellor as and when he/she is appointed by the Ministry of Education who may take a call in the matter.

45-6.1		<p>Implementation of MoE SAMARTH ERP Module at the Central University of Rajasthan</p> <p>After the meeting, there was a brief discussion regarding implementation of SAMARTH ERP Module at the University. The Vice Chancellor informed that the university was making use of SAMARTH Portal for few modules viz. Employee Management, Leave Management, RTI, Inventory Management, Estate <i>etc.</i> and is in process for implementing few other modules like Recruitment, PayRoll Management, <i>etc.</i> However, the university has been facing certain problems at the back-end. Also, it was observed that the SAMARTH Portal did not have an integrated module covering the complete life-cycle of the student from the Admission to Course Registration, Assessment, Declaration of Result, and issue of the Provisional Marksheet. Similarly, there was need for customization/minor modifications in other modules as per the requirements of the university. The requests for the same have already been sent to the SAMARTH Team. It was decided that SAMARTH Team will coordinate with CURaj and take up the modifications to facilitate implementation of the SAMARTH Modules.</p>
