Vivekanand Tiwari, Assistant Professor, Department of Architecture has been permitted by the IIT Roorkee for yet another one year extra. Therefore, Executive Council authorized the Vice Chancellor to take decision in this regard.</p>
46-5.18	<p>Matter of Relieving of Prof. Ram Lakhan Meena from the Post of Professor at Central University of Rajasthan</p> <ol style="list-style-type: none"> 1. Prof. Ram Lakhan Meena joined the Central University of Rajasthan on 14 August 2013 as Professor under the School of Humanities & Languages after applying through proper channel and after getting relieved from his parent organization Satyawati College, University of Delhi, Delhi. 2. After successful completion of the stipulated probation period of one year, the Executive Council in its 19th Meeting held on 27 May 2015 [Item 19-4.1] resolved to confirm Prof. Meena from the date of completion of probation period. A letter dated 03.06.2015 was prepared in this regard. 3. Prof. Ram Lakhan Meena submitted a request vide letter No. RLM/HoD/Hindi/ Lien/ 2015-16/07 dated 10.06.2015 to continue in lien as per the decision/implementation of the "mobility of faculty and non-faculty personnel to the newly established Central Educational Institutions (CEIs)" as conveyed vide MHRD letter F.No. 8-9/2008-TS.I dated 13.08.2014. The UGC vide its letter F.No.51-1/2009(CU) dated 13 January 2012 clarified that the employees coming from pensionable establishments would be governed by pension scheme of parent department till such time they retain the lien with the parent post. In other words employees of new organizations (established on or after 01.01.2004) will be governed by New Pension Scheme (NPS). 4. On the above request, the Executive Council in its 20th meeting dated 29 June 2015 resolved that "<i>matter may be taken up with his parent organization regarding his lien in light of recent instructions issued by the Ministry of HRD for mobility of faculty. The confirmation order may be withheld till the decision in the matter.</i>" 5. As resolved by the Executive Council in its 20th Meeting the matter was taken up with the parent organization of Prof. Ram Lakhan Meena and as communicated by Satyawati College (University of Delhi) vide its letter SC/Admn/549/2015 dated 12 October 2015, lien in respect of Prof. Meena was extended for another period of one year with effect from 14 August 2015. 6. <i>The Executive Council in its 22nd meeting (Item No.22-4.7) deliberated on the issue and reiterated that Prof. Meena is currently on EOL with extended lien (One year w.e.f. August 14, 2015) from Satyawati College, University of Delhi, Delhi till August 13, 2016. So long as he continues to be on EOL with lien (as per his own request) by holding a substantive position at his parent organisation, his confirmation at Central University Rajasthan cannot be considered. Hence, in view of continuation of his lien, he is considered to be on probation (as confirmation and lien both together are not feasible) till August 13, 2016. He is to be advised (to ensure smooth running of courses) to choose the option of being confirmed at Cen-</i>

As resolved by the EC, Letter No. CURAJ/R/F.78/2016-17/70 dated 11.04.2016 was issued to Prof. Meena.</i></p> <p>7. In response to the university letter dated 11.04.2016, Prof. Meena submitted a letter dated 26.07.2016 informing to choose the option to stay at CURaj subject to the outcome of the Court Case Writ No. 5825/2016.</p> <p>8. The matter related to Prof. Meena was placed before the Executive Council in its 24th Meeting held on 10.08.2016 - <i>"It was resolved unanimously as follows:</i> <i>a) Prof. R. The case details is enclosed for reference.</p> <p>11. On the complaint received from Dr. Ram Lakhan Meena, regarding his relieving from the post of Professor without any reasons, this University has recently apprised the details of the matter to the Ministry of Education vide letter No. 997 dated 18.08.2021 [Annexure-N Page No. : 160 to 199].</p> <p>12. Ministry of Education vide their letter F.No. 48-9/2020- CU.III dated 14.10.2021 [Annexure-O Page No. : 200] has stated that "Dr. Ram Lakhan Meena, Prof. Deptt. Of Hindi, CU Rajasthan was relieved from the University without confirmation of his Professorship and by that time his lien ended at his parent University i.e. Delhi University rendering him jobless. He has already completed 18 years of service in DU and now without any job. It may be noted that the deputation upto 10 years is allowed as per the instructions issued vide this Ministry's OM dated 13th October, 2014 regarding mobility of faculty and non-faculty personnnel to the newly established Central Educational Institutions (CEIs). It is, therefore, requested that you may re-consider Dr. Ram Lakhan Meena's case and take a decision in the matter".</p> <p>13. The matter was placed before 45th Executive Council Meeting held November 23, 2021. The Executive Council resolved as under: <i>"The matter was deliberated. Prof. J. S. Rajput observed that the case is sub-judice, complex, and has far reaching implications; as such, ideally, it should not have been placed by the In-charge Vice Chancellor before the Executive Council. After brief discussions on the letter dated 14.10.2021 of the MoE, it was decided that the same must be placed before the regular Vice Chancellor as and when he/she is appointed by the Ministry of Education who may take a call in the matter."</i></p> <p>Regular Vice Chancellor has been appointed on 14.01.2022 and has joined the University on 24.01.2022.</p> <p>In view of this, the matter is placed before the Executive Council for information and further directions in the matter.</p> <p>Resolution: The matter was discussed in detail. It was mentioned that in 45th Meeting of the Executive Council, the observation of the Executive Council was mentioned in the name of Prof. J. S. Rajput.
