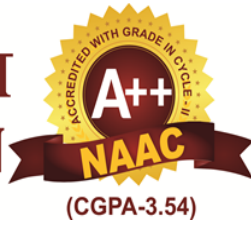

A Master's Degree with at least 55% (or an equivalent grade in a point-scale, wherever the grading system is followed) from recognized University in the subject Education / Distance Education / Computer Science / Computer Application / Statistics / Mathematics / Commerce and Management / Social Science / Language. .</li><li>3. A minimum of ten years of teaching experience in university/ college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/ National Level Institutions with evidence of having successfully guided doctoral candidate.</li></ol>

### **Terms & Conditions:**

- 1. Those candidates, who have applied earlier against the Advt. No. CURAJ/4454 dated 13.03.2024, need not to apply again. Their previous applications will be considered.**
- The role of the Director- Open & Distance Learning and Online Programme will be as per the UGC Notification dated 4<sup>th</sup> September, 2020 for Establishment of recognised programmes under Online mode shall have a Centre for Online Education for effective coordination among its Departments or Schools of Studies for offering the Online Programme, comprising Admission or Registration Unit, Examination Unit and Technology Support Unit. The Centre for Online Learning shall maintain and administer the Centralised Data Base of all the recognised programmes.
- The services of candidate will be governed by Act, Statutes, Ordinances, Rules and Regulations, administrative decisions and orders of the University which are in force at present and as may be amended/ modified from time to time.
- The selected candidate will be entitled for per month consolidated amount commensurate to the eligibility, subject to necessary deduction for availing accommodation facility in the University Campus (as per the availability), which will remain the same throughout the contract period.
- The candidate will not be entitled to any other benefits, which are admissible to the regular employees of the Central University of Rajasthan.
- This appointment will not vest any right to claim for regular appointment in the University or for continued services in the University.
- The University reserves the right to terminate this appointment any time even before the stipulated period in case of unsatisfactory performance, misconduct or any other administrative reasons/ compulsions.
- On expiry of the period of the engagement, the candidate will not be required to turn up for duties unless the period of engagement is renewed based on performance and requirement and the decision of the Competent Authority.
- On expiry of the period of this appointment as per the offer of appointment, the candidate will not be required to turn up for duties unless the further extension is provided by the university.
- In case of any dispute/ ambiguity that may occur in the process of selection, the decision of the University shall be final.
- The candidate will have to perform such other duties and work as assigned by the Central University of Rajasthan from time to time.
