## **<u>Requirement for the post of Director (Research & Development)</u>**

(Ref.: CURAJ/R/F155/Rectt./2024/4465 Date: 13.03.2024)

## Terms & Conditions:

- 1. The role of the Director (R&D) will be as per the UGC Guidelines for Establishment of Research & Development Cell in Higher Education Institutions which are in force and as amended from time to time.
- 2. The services of candidate will be governed by Act, Statutes, Ordinances, Rules and Regulations, administrative decisions and orders of the University which are in force at present and as may be amended/ modified from time to time.
- 3. The selected candidate will be entitled for consolidated amount of Rs. 150000/-(Rupees One Lac Fifty Thousand Only) per month, subject to necessary deduction for availing accommodation facility in the University Campus (as per the availability), which will remain the same throughout the contract period.
- 4. The candidate will not be entitled to any other benefits, which are admissible to the regular employees of the Central University of Rajasthan.
- 5. This appointment will not vest any right to claim for regular appointment in the University or for continued services in the University.
- 6. The University reserves the right to terminate this appointment any time even before the stipulated period in case of unsatisfactory performance, misconduct or any other administrative reasons/ compulsions.
- 7. On expiry of the period of the engagement, the candidate will not be required to turn up for duties unless the period of engagement is renewed based on performance and requirement and the decision of the Competent Authority.
- 8. On expiry of the period of this appointment as per the offer of appointment, the candidate will not be required to turn up for duties unless the further extension is provided by the university.
- 9. In case of any dispute/ ambiguity that may occur in the process of selection, the decision of the University shall be final.
- 10. The candidate will have to perform such other duties and work as assigned by the Central University of Rajasthan from time to time.
- 11. If it is detected by the Central University of Rajasthan during the period of appointment that academic credentials/age/experience are without standing, fake or substandard or your documents are false, fabricated, manufactured, tampered with or the candidate is not eligible for the post as per the prescribed educational qualifications and experience etc. which could not be detected at the time of selection due to whatever circumstances, the appointment shall be terminated forthwith and action will be initiated against the candidate as per rules.
- 12. In case of any dispute/suit or legal proceeding arises against the University, the Jurisdiction shall be restricted to the Rajasthan High Court Bench Jaipur.
