# **GENERAL TERMS & CONDITIONS**

- **1.** The qualifications, emoluments and conditions of service, including age of superannuation, shall be as prescribed by the University/ UGC/ Govt. of India, as amended from time to time.
- **2.** Candidates are advised to ensure/satisfy themselves before applying that they possess at least the minimum essential qualifications laid down in the advertisement and ensure that they fulfil all the eligibility norms.
- **3.** Wherever grading system is followed, equivalent grade point is required.
- **4.** It is the responsibility of the candidate to assess his own eligibility for the post for which he/ she is applying in accordance with the prescribed qualification, experience etc. Suppression of factual information, supply of fake documents, providing false or misleading information or any other undesirable action by the candidate shall lead to cancellation of his candidature.
- **5.** The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for the trade test/written test/interview as the case may be. Where the number of applications received in response to an advertisement is large and it is not feasible or convenient to interview all the candidates, the University at its discretion, may restrict the number of candidates to a reasonable limit on the basis of qualifications / experience higher than the minimum prescribed for the post. - (iii) The post of Internal Audit Officer shall be filled up on Deputation for a maximum period of three years.
- (iv) The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of application. This age limit may not be applicable for appointment on contract basis.
- **12.** Canvassing in any form may lead to cancellation of candidature.
- **13.** The University reserves the right:
