Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the Central University of Rajasthan, 'Bandar Sindri (District Ajmer) for the year 2016-17

We have audited the attached Balance Sheet of the Central University of Rajasthan (CUR), Bandar Sindri, Ajmer as at 31 March 2017, the Income & Expenditure Account and Receipt & Payment Account for the year ended on that date under Section 19(2) of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with Section 31 (1) of the Central University Act, 2009. These financial statements are the responsibility of the Central University of Rajasthan's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (C&AG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/C&AG's Audit Reports separately.

3. We have conducted our audit in accordance with the auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on our audit, we report that:

- i. We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
- ii. The Balance Sheet, Income & Expenditure Account and Receipt & Payment Account dealt with by this report have been drawn up in the format approved by Ministry of Human Resources Development, Government of India vide order No.29-4/2012-FD dated 17 April 2015.
- iii. In our opinion, proper books of accounts and other relevant records have been maintained by the Central University of Rajasthan, Bandar Sindri, Ajmer as required in so far as it appears from our examination of such books.



iv. We further report that:

Comments on Accounts:

A Balance Sheet

A.1 Assets

A.1.1 Fixed Assets (Schedule-4)

A.1.1.1 Capital works-in progress: Rs 416.93 crore

It includes Rs 297.32 crore incurred on construction/completion of various Buildings of the University which were being utilized for the intended purposes but not capitalized as fixed assets and shown as Capital work in progress. Further, due to non-capitalisation of these buildings, depreciation Rs 14.86 crore @ 5 per cent on Written Down value method for the year 2016-17 could not be charged on this asset.

It resulted in understatement of Fixed Asset (Buildings) by Rs 282.46 crore and deficit by Rs 14.86 crore and overstatement of Capital work in progress by Rs 297.32 crore.

A.1.2 Capital work-in progress (Schedule-4) : Rs 416.93 crore

It includes capital advance of Rs 850.18 lakh given for various works. According to instructions contained in formats of financial statements for Central Higher Educational institutions issued by the MHRD, advance payments on Capital Account was to be booked/shown in Schedule-8 Loans, Advances & Deposits.

It resulted in overstatement of Capital work in progress and understatement of Loans, Advance and Deposits (Schedule-8) by Rs 850.18 lakh.

A.1.3 Fixed Assets (Schedule-4):

Tangible Assets Rs 27.88 crore

Scientific & Laboratory equipments: Rs 14.43 crore

It includes an expenditure of Rs 5.23 lakh incurred on purchase of computers/peripherals which was booked under the Head Scientific & Laboratory equipment instead of booking the same under the Head Computers and peripherals. Thus due to classification of the computers/desktop/UPS under the Head Scientific & laboratory equipment depreciation was charged at 10 per cent instead of 30 per cent applicable on computers/peripherals.

It resulted in understatement of depreciation by Rs 1.05 lakh and understatement of deficit by Rs 1.05 lakh and overstatement of fixed assets to that extent.



B Grant – in – Aid

During the financial year 2016-17, CUR received Plan Grant-in-aid of Rs 65.31 crore from University Grants Commission. Balance of unadjusted/unspent grant of Rs 18.43 crore of previous year was available in the beginning of the year. Out of total sum of Rs 83.74 crore, the Institute utilized a sum of Rs 57.46 crore leaving a balance of Rs 26.28 crore as unutilized Plan Grant at the end of financial year.

C. Net Impact of Comments on Accounts

The net Impact of comments given in the preceding paragraphs is that as on 31st March 2017, the assets were overstated by Rs 1487.05 lakh and deficit was understated by Rs 1487.05 lakh.

D. Management letter

Deficiencies, which have not been included in the Separate Audit Report, have been brought to the notice of the Management through a management letter issued separately for remedial/corrective action.

- v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipt & Payment Account dealt with by this report are in agreement with the books of accounts.
- vi. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters, stated above and other matters mentioned in Annexure to this Separate Audit Report give a true and fair view in conformity with accounting principles generally accepted in India.
 - a. In so far as it relates to the Balance Sheet, of the state of affairs of the Central University of Rajasthan, Bandar Sindri, Ajmer as at 31 March 2017, and
 - b. In so far as it relates to Income & Expenditure Account of the deficit for the year ended on that date.

- However, no Internal Audit Manual has been prepared as yet.
- As such, the Internal audit system was inadequate.

SCHEDULE 23 - SIGNIFICANT ACCOUNTING POLICIES

1. BASIS FOR PREPARATION OF ACCOUNTS

The accounts are prepared under the Historical Cost Convention unless otherwise stated and generally on the Accrual method of accounting.

2. REVENUE RECOGNITION

- 2.1 All the Academic Receipts such as Student Fees, Hostel Fees etc, Sale of Admission Forms and Royalty are accounted on cash basis and all other incomes are generally on Accrual basis.
- 2.2 Income from Land, Buildings and Other Property and Interest on Investments are accounted on accrual basis.
- 2.3 Interest on interest bearing advances to staff for House Building, Purchase of Vehicles and Computers is accounted on accrual basis every year, though the actual recovery of interest starts after the full repayment of the Principal.

3. FIXED ASSETS AND DEPRECIATION

- 3.1 Fixed assets are stated at cost of acquisition including inward freight, duties and taxes and incidental and direct expenses related to acquisition, installation and commissioning of the assets.
- 3.2 Gifted / Donated assets are valued at the declared value where available; if not available, the value is estimated based on the present market value adjusted with reference to the physical condition of the assets. They are set-up by credit to Capital Fund and merged with the Fixed Assets of the University. Depreciation is charged at the rates applicable to the respective assets.
- 3.3 Books received as gifts, are valued at selling prices printed on the books. Where they are not printed, the value is based on assessment.
- 3.4 **Lease Hold Land:** Government of Rajasthan vide its letter reference No. 5805 dated 02.07.2010 allotted 1296.07 Bigha's of land (209.83 Hectare equivalent to approx 518.428 Acres of land) free of cost to the Central University of Rajasthan effective from 09.03.2010 on lease for 99 years. The same has been shown under lease hold land on a nominal value of Re. 1/- and corresponding credit has been given to Corpus/Capital Fund.

- 3.5 **Capital Work in Progress:** Constructed value of the works under construction/ongoing works, Deposits and Advances given against various work / procurement of Assets not capitalised up to the close of financial year are treated as capital work in progress.
- 3.6 Fixed assets are valued at cost less accumulated depreciation. Depreciation on fixed assets is provided on Written down value method, at the following rates:

- 3.7 (i) The depreciation is charged for the full year if the assets are acquired up to 30th September, otherwise it is 50% of the above rate for Sr. No. 3 to 18 and depreciation for the assets mentioned at Sr. No. 19 & 20 are charged on the rate as mentioned above, irrespective of the date of purchase & cost.
- (ii) The depreciation on the individual assets costing less than or equal to Rs. 5,000/- (except Library books) is charged @ 100%, leaving an original value of Re. 1/- per asset. However physical accounting and control are continued by the holders of such assets.
- 3.8 Where an asset is fully depreciated, it will be carried at a residual value of Re. 1/- for each assets in the Balance Sheet and will not be further depreciated. Thereafter, depreciation is calculated on the additions of each year separately at the rate of depreciation applicable for that asset head.
- 3.9 Assets created out of Earmarked Funds and funds of Sponsored Projects, where the ownership of such assets vests in the University, are setup by credit to Capital Fund and merged with the Fixed Assets of the University. Depreciation is charged at the rates applicable to the respective assets. No depreciation is provided on assets created out of Sponsored Project funds or any other such fund/scheme, where the ownership is retained by the sponsors but held and used by the University. These assets are debited to respective fund account and accordingly no capital funds are created and also, separately disclosed in the Notes on Accounts.
- 3.10 Expenditure on acquisition of software such as operating systems which are generally purchased along with computer & peripherals are capitalized along with the value of computer & peripherals and accordingly depreciation are charged as per rates applicable for computer & peripherals.
- 3.11 Electronic Journals (E-Journals) are separated from Library Books in view of the limited benefit that could be derived from the on-line access provided. E-journals are not in a tangible form and also these are required to renew on yearly basis, as such not capitalized but accounted as recurring expenditure every year.

4 INTANGIBLE ASSETS

- 4.1 Patents and copy rights are grouped under Intangible Assets. The expenditure incurred from time-to-time (application fees, legal expenses etc.) for obtaining Patents is temporarily capitalized and shown as part of Intangible Assets in the Balance Sheet. If applications for patents are rejected, the cumulative expenditure incurred on the particular patent is written off to the Income & Expenditure Account in the year, the application is rejected.

4.2 Software and E - Books are shown separately, under Intangible Assets. Depreciation on E-Books are charged as applicable for Library Books.

5 STOCKS

Expenditure on purchase of chemicals, glassware, publications and other stores including stationary and other consumables is accounted as revenue expenditure, except that the value of closing stocks held on 31st March is set up as inventories by reducing the corresponding Revenue Expenditure on the basis of information obtained from Departments. They are valued at cost.

6 RETIREMENT BENEFITS

6.1 Retirements benefits i.e., pension - employer contribution to NPS and leave encashment are provided on accrual basis. Capitalized Value of pension and gratuity received from previous employers of the Institution's employees, who have been absorbed in the Institution, is credited to the respective Provision Accounts. Pension contribution received in respect of employees on deputation is also credited to the Provision for Pension Account. The Actual payments of Pension, Gratuity and Leave encashment are debited in the Accounts to the respective provisions.

6.2 Liability for leave Encashment & Gratuity are provided as per Actuarial valuation.

7 INVESTMENTS

7.1 Long term investments are carried at their cost or face value whichever is lower. However any permanent diminution in their value as on the date of the Balance Sheet is provided for.

7.2 Short Term investments are carried at their cost or market value (if quoted) whichever is lower.

7.3 Cost includes acquisition expenses like brokerage, transfer stamps etc.

8 EARMARKED FUND & INTEREST INCOME

Interest received and due on such funds are added to the respective funds and not treated as income of the University.

9 ENDOWMENT FUND

Endowment are funds, received from various individual donors, trust and other organizations for establishing chairs and/or for medals and prizes etc., as specified by the donors. Interest received and due on such funds are added to the respective Funds. The expenditure on chairs, medals and prizes etc. is debited to the respective endowment funds and the balance is carried forward.

10 GOVERNMENT AND UGC GRANTS

10.1 Government Grants and UGC grants are accounted on realization basis. However, where a sanction for release of grant pertaining to the financial year is received before 31st March and the grant is actually received in the next financial year, the grant is accounted on accrual basis and an equal amount is shown as recoverable from the Grantor.

10.2 To the extent utilized towards capital expenditure, (on accrual basis) government grants and grants from UGC are transferred to the Corpus/Capital Fund.

10.3 Government and UGC grants for meeting Revenue Expenditure (on accrual basis) are treated, to the extent utilized, as income of the year in which they are realized.

10.4 Unutilized grants are carried forward and exhibited as a liability in the Balance Sheet.

10.5 Subsidy received for installation of Solar Systems/Equipments is shown under Corpus/Capital Fund.

10.6 Surplus/deficit of income/expenditure account if any, are transferred to Corpus/Capital Fund except the interest earned on recurring & salary grant which are added/transferred to respective unutilized grant.

10.7 Interest earned on non-recurring grant received from UGC have been credited to the Non Recurring unutilised grant.

11 SPONSORED PROJECTS

11.1 In respects of ongoing Sponsored Projects, the amounts received from sponsors are credited to the head "Current Liabilities and Provisions -Current Liabilities -Other Liabilities -Receipts against ongoing sponsored projects." As and when expenditure is incurred against such projects, the concerned project account is debited with allocated expenditure head i.e. the liability account.

11A SCHOLARSHIP

11A.1 In addition to the Junior Research Fellowships & GATE Scholarship funded by the University Grants Commission, Fellowships and Scholarships are also sponsored by various organizations, are accounted in the same way as Sponsored Projects.

11A.2 The Institution itself also awards Fellowships and Scholarships, such as Non NET/JRF etc. which are accounted as Academic expenses. University Merit Scholarship are paid from merit scholarship fund (which has been created from the income of the University) and debited to the same fund.

12 MISCELLANEOUS EXPENDITURE

Deferred revenue expenditure is written off over a period of 5 years from the year it is incurred.

13 FOREIGN CURRENCY TRANSACTIONS

13.1 Transactions denominated in foreign currency are accounted at the exchange rate prevailing at the date of the transaction.

13.2 Foreign currency loans converted at the exchange rate prevailing as at the year end and the resultant gain/loss is considered to revenue.

14 INCOME TAX

The income of the University is exempted from Income Tax under Section 10 (23C) of the Income Tax Act, as such no provision for taxation is made in the books of Accounts.

15 REVISED FORMAT

New format of Accounts has been implemented from the Financial Year 2014 - 15. Previous years figures/opening balances are regrouped/re-arranged, wherever required as per data available.

Also, depreciation on all assets, has been recalculated since beginning and the consequential effect / differences found are shown under deductions/adjustment head of Depreciation under Schedule 4. Depreciation related to prior period is also shown under this schedule only, since as per new format of accounts Schedule 22 - Prior Period Expenses, the expenditure head-Depreciation is not included.
- 3.5 DDUKK is a sponsored/specified scheme of UGC and not a regular activity. Assets created under this scheme is directly debited to Grant A/c and no depreciation is charged.

- 11.2 First time Actuarial Valuation for leave balance (EL+HSPL, subject to maximum of 300 days) of all Teaching and Non-Teaching Employees has been made as on 31-03-2017 and accordingly differential amount of Rs. 2,05,20,381/- {i.e. total calculated liability as on 31-03-2017 - Rs. 3,22,13,897/- minus liability lying in the books (Rs. 1,20,56,136/- minus Rs. 3,62,620/-)} is provided as additional expenditure during the Financial Year.
- 11.3 University has received a letter no. F.1-2/2004 (CU) dt. 27-04-2015 from UGC mentioning that in case of late remittance of NPS contribution in PFRDA due to some administrative reason, such as late registration of beneficiary etc., interest at the rate as applicable to GPF deposits from time to time may be allowed and be remitted alongwith NPS contribution. The same has not yet been calculated up to balance sheet date and as such, has not been accounted nor quantified in Books/Notes to Accounts.
- 11.4 Interest liability on transferred liability of CPF, Gratuity, EL Encashment etc. received from other institutions has not been provided, in absence of directives/ final decision on the matter.
- 12 12.1 Expenditure on Plantation, procurement of mess equipment and RO System is not yet capitalised for want of expenditure details and completion certificate from CPWD-CURAJ projects/Estate Section.
- 12.2 Various Hostel Buildings, Bank Building, VC Bungalow and some other structures are not yet capitalised in the Books of Accounts for want of complete expenditure details, final completion certificate from CPWD/concerned section. Till date these buildings are not yet taken over by the University, formally. After receipt of complete expenditure details, completion certificate and certificate of taking over, the same will be capitalised and depreciation will be charged, as per Generally Accepted Accounting Principles. A new committee has been constituted for verification and taking over the completed works. Taking over certificate/report is awaited. Since University is using the completed building to cater its various needs, accordingly expenditure incurred on a/c of repair & maintenance of the buildings are accounted under Recurring (Expenditure) head.
- 12.3 Provisional Rent payable to R. K. Patni Govt. College, still pending amounting to Rs. 67,16,742/-.
- 13 Expenditure on purchase of chemicals, glassware, plasticwares, stationary & other consumables are accounted as revenue expenditures except for the value of closing stocks held on 31st March, 2017. Closing Stock of these items as certified by concerned departments are set up as inventories by reducing the corresponding revenue expenditures. They are valued at cost.

- 14 University is receiving its Grants from UGC under XII plan allocation directly into its SB A/c No. 666110210000002. Calculation of Interest has been made in the ratio of opening balance plus Grant received under the head Non - Recurring, Recurring & Salary).
- 15 The NPS scheme is owned by the members of NPS and not by the University, accordingly University has opened a separate bank account with Bank of India, Central University branch for the operation of transactions of NPS. Separate Balance Sheet, Income & Expenditure accounts and Receipt & Payment accounts has been prepared for the same.
- 16 Central University of Rajasthan has been assigned to conduct Central University Common Entrance Test for the Academic Year 2013-14, 2014-15, 2015-16, 2016-17 & 2017-18. Number of Participating University during 2013-14 were 10, during 2014-15 were 7, during 2015-16 were 8, during 2016-17 were 9 and during 2017-18 are 10. University has maintained separate books of Accounts as well as separate bank account for recording all accounting transaction of the said activities. All the receivables & payables, Assets & Liabilities belongs to the participating Universities. The Accounts of CUCET are being prepared separately. Accordingly the accounts of these activities are not shown with the accounts of the CURAJ.
- 17 University Share of overheads in respect of some sponsored projects is accounted as per information received. The transferred amount of University share of Overhead has been kept separately and distinctively in the Project Account. Transfer of University share of Overhead for some remaining projects, are under process, in the books of Project accounts.
- 18 During the Audit for the Year 2015-16 by the C&AG, the Audit Party observed that a sum of Rs. 7,02,149/- on account of payment of Service Tax made to M/s Gurubani Security Services Pvt. Ltd for the peirod from May 2013 to March 2014 was not in order. At present, there is a sufficient amount lying with the University to recover this amount from the said agency. However, the amount of Rs. 7,02,149/- will be retained, till the final decision taken by Competent Authority.
- 19 An amount of Rs. 354.94 Lakhs has been received from UGC for providing the Campus Wide networking & Wi-fi facilities at the University. For this work, the MHRD has identified M/s NICS I for implementing the project, as a Nodal Agency. An amount of Rs. 103.67 Lakhs has been released to M/s NICS I on account of advance payment against P.O. raised by them. This project is under implementation stage and not yet commissioned, as such the total amount of Grant received has been shown under Sch. 3 - Current Liabilities & Provisions and the amount of advance given has been shown under Sch. 8 - Loans Advances & Deposits.

- 21 In view of the various O.M. issued by the Ministry of Finance and MHRD and latest O.M. no. eFTS 320419/E.III(A)/2016 dated 09.01.2017 received from Govt. of India, Ministry of Finance, Department of Education, no provision for payment of Ad-hoc bonus i.r. of F.Y. 2016 - 17 has been made.
- 22 Fee received under M. Sc. Bed. Programme are credited to University Account for M. Sc. Programme period. Fee in respect of B.Ed. Programme will be credited to School of Education account when student will get enter into B.Ed. Programme .
- 23 From the Financial Year 2015 - 16, the separate books of accounts have been maintained for the following:
- i) Central University of Rajasthan
 - ii) School of Education
 - iii) Community College/Deen Dayal Upadhyay Kaushal Kendra Scheme
 - iv) Sponsored Projects

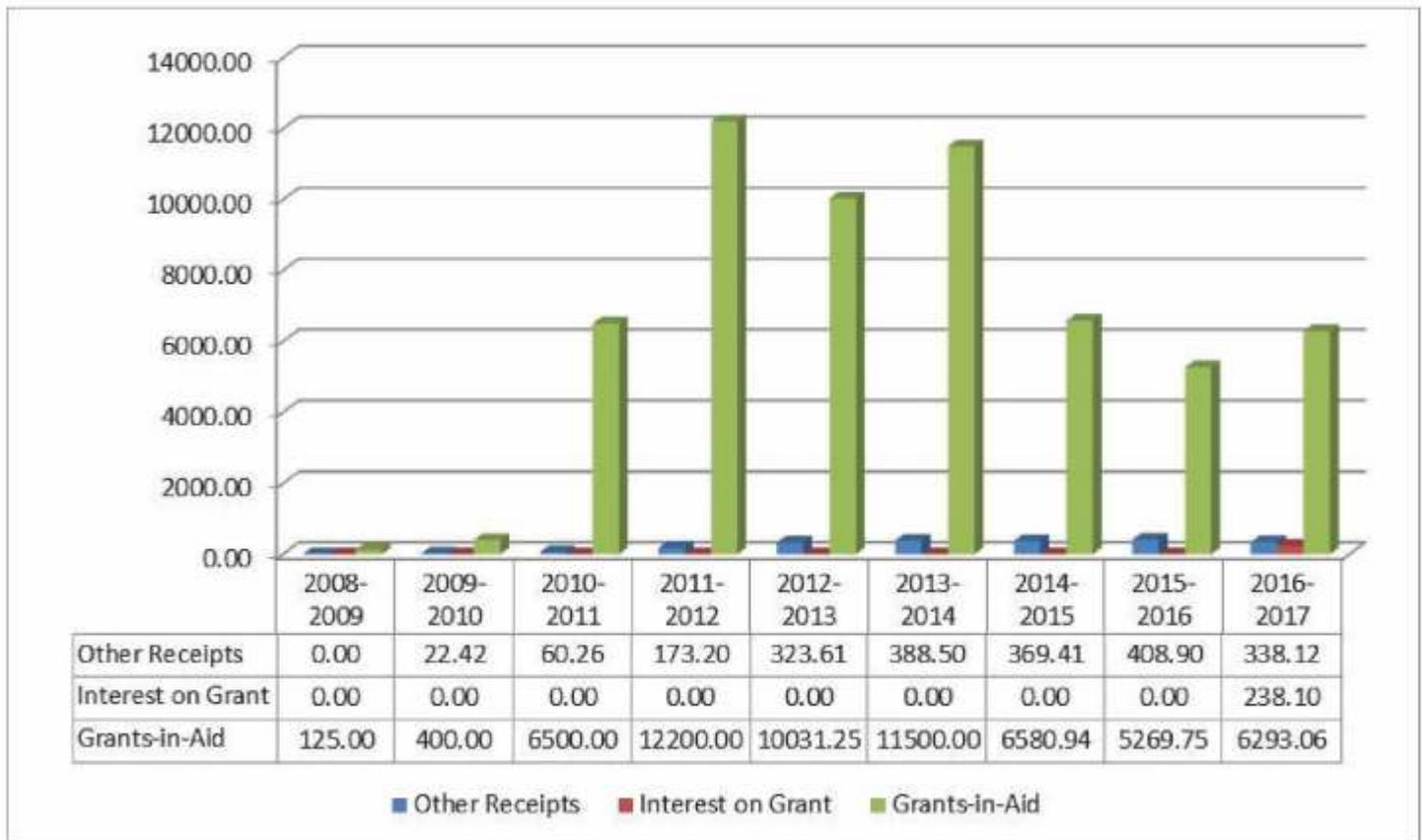

(Amount – Rs. in Lacs)

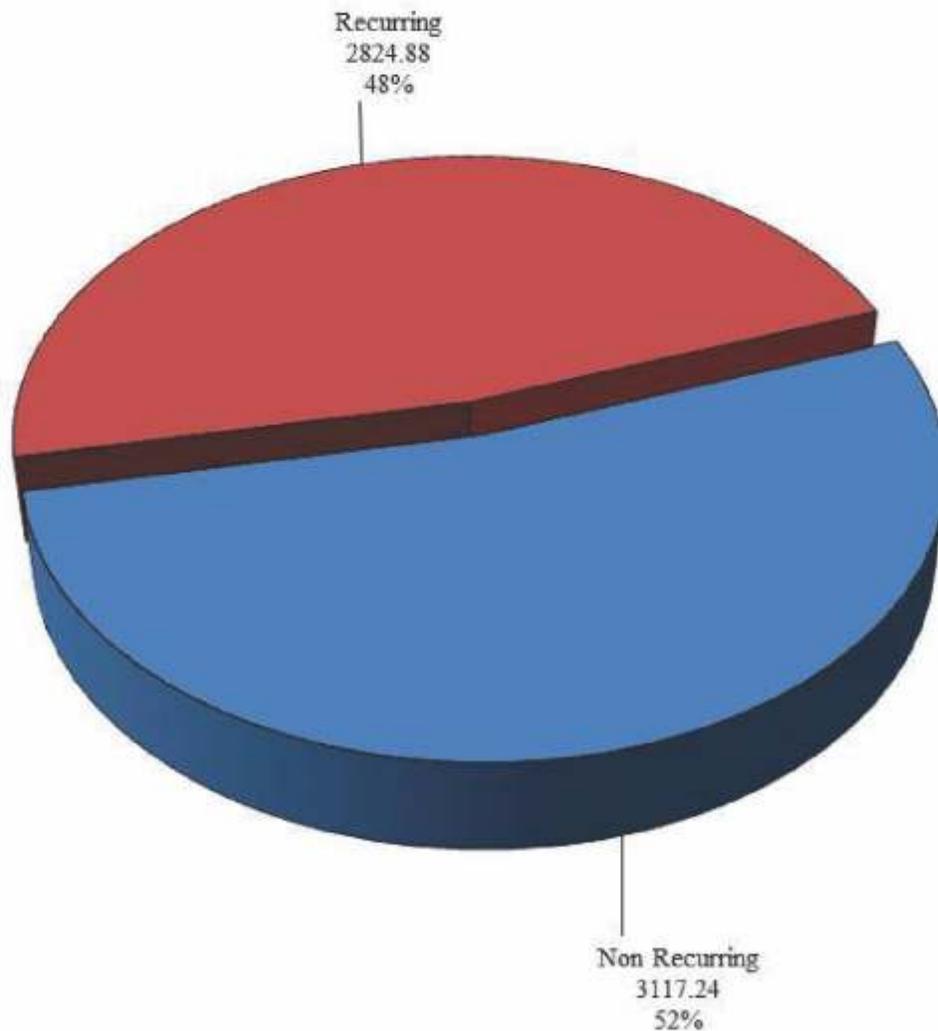

(Amount – Rs. in Lacs)

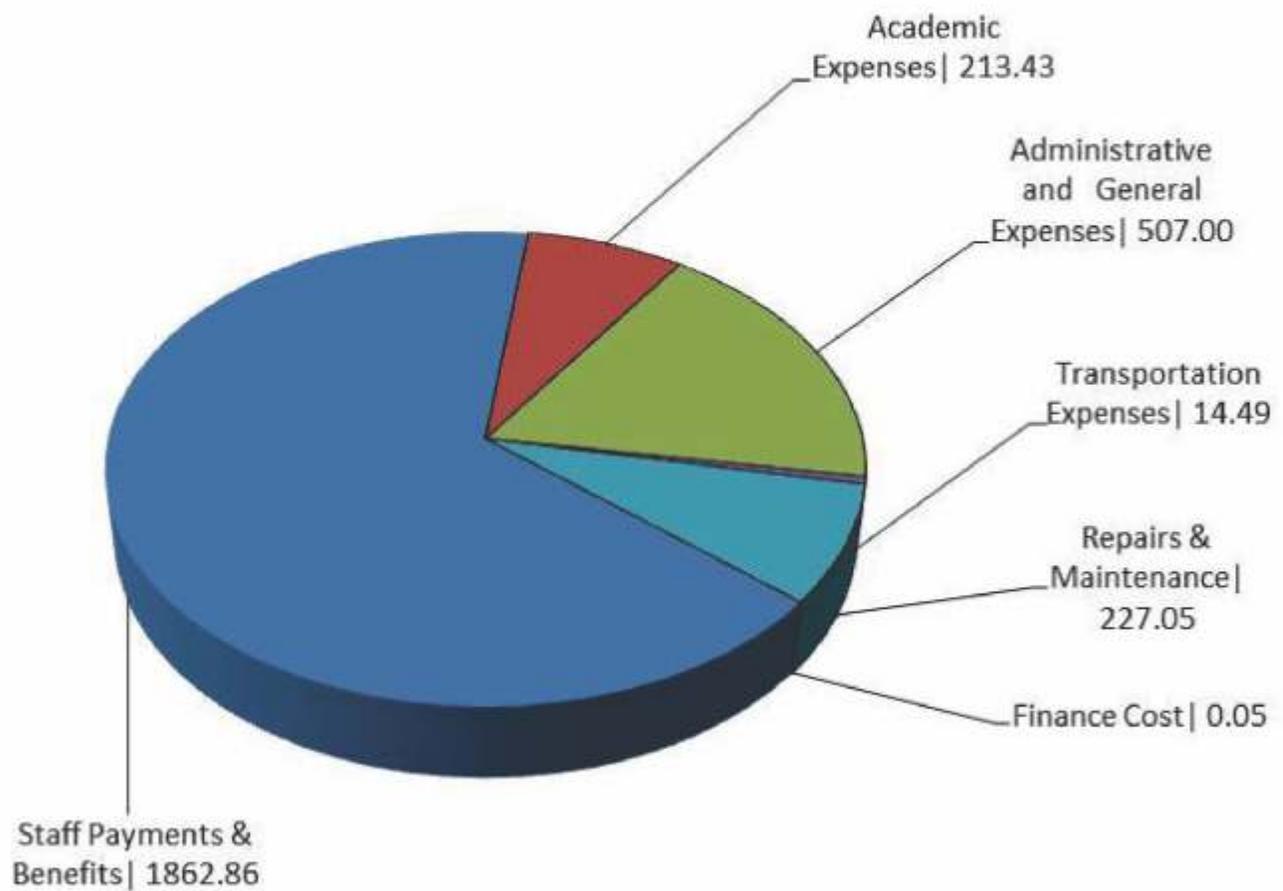

(Amount – Rs. in Lakhs)



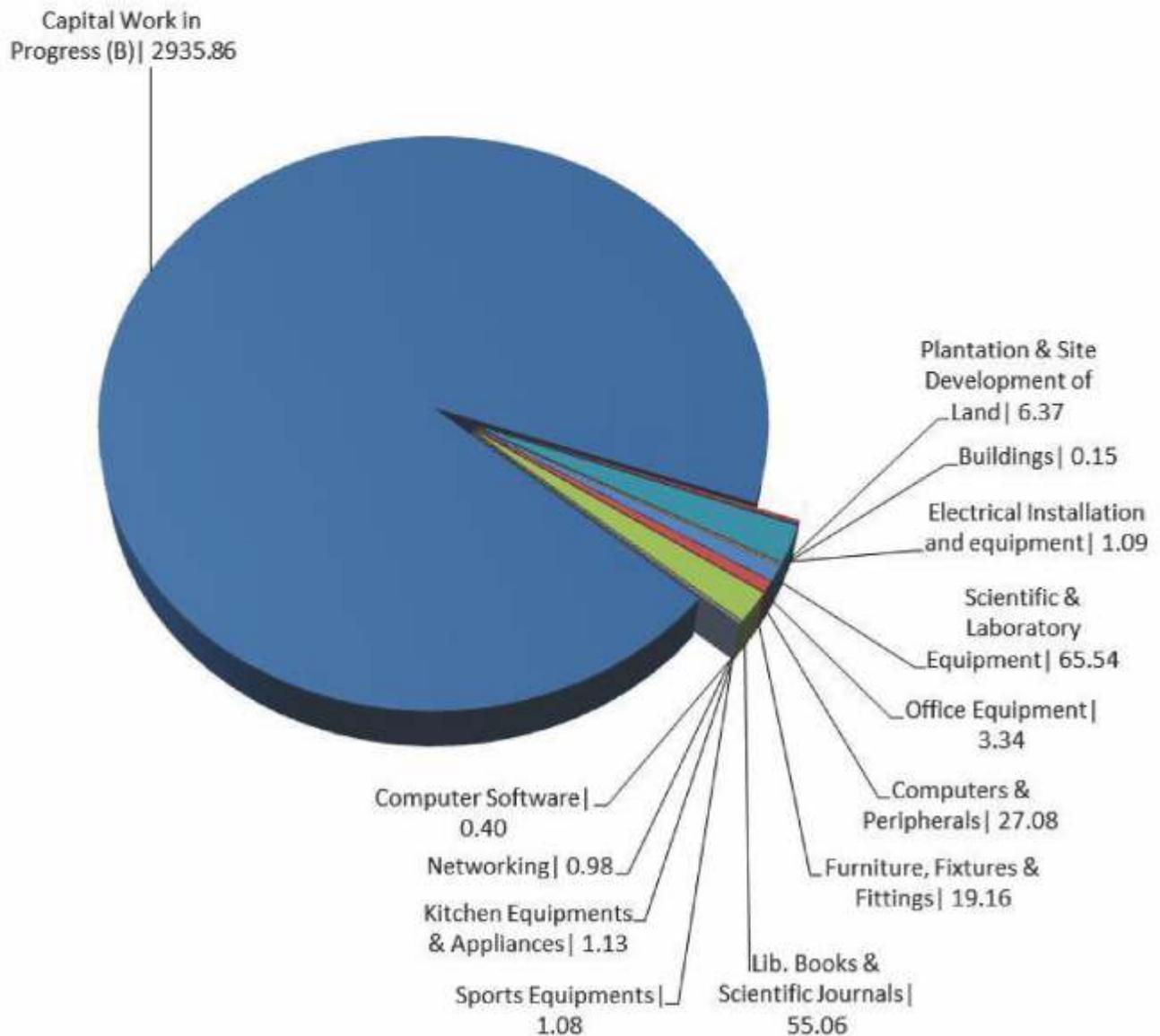
