ORDER


1. Whereas, the AICTE is a statutory body established by AICTE Act, 1987. The said Act "provides for establishment of an All India Council for Technical Education with a view to the proper planning and coordinated development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith."
2. Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps as it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards. Further, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned.
3. Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Institutions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Hand book for approval process which details out the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
4. Whereas, **Central University of Rajasthan, City Road, Kishangarh, Ajmer-305801, Rajasthan** was approved in the year 2011 and subsequent EOA were issued upto 2018-19 for running **Architecture and Planning, E&T and Management** Program.
5. Whereas, the Institute has applied for Extension of Approval for A. Y. 2019-20 with introduction of **PIO/FN/Gulf Quota/OCI** under Chapter II of Approval Process Handbook 2019-20. EVC was conducted to the Institute on 26.03.2019 as per norms, the EVC team has noted deficiencies. The EVC report was uploaded on Web Portal and the Institute was informed to appear before Standing Hearing Committee.
6. Whereas, the Standing Hearing Committee (SHC) was held on 30.03.2019 where the institute representative was **ABSENT**. The recommendation of SHC based on the deficiencies noted by EVC are as under: -

"EOA is not recommended for A. Y. 2019-20".
7. Whereas, the Institute was given an appeal before Standing Appellate Committee (SAC) held on 12.04.2019 where the representative of the Institute was present before the Committee. The Committee heard the representative and made the following recommendations:-
"EOA recommended for 2019-20, PIO/FN/Gulf Quota/OCI not recommended."
8. Therefore, after examining the entire matter in the facts and circumstances mentioned herein above, and in terms of the provision of the Approval Process Hand Book, for the A/Y 2019-20 and also the terms and conditions mentioned in the Letter of Approval, it has been decided to grant **Extension of Approval without**

PIO/FN/Gulf Quota/OCI for A. Y. 2019-20 to Central University of Rajasthan, City Road, Kishangarh, Ajmer-305801, Rajasthan

9. It may be noticed that clause 2.5.3 of Approval Process Handbook 2019-20 is implemented on the courses run by the Institutes, wherever applicable.
