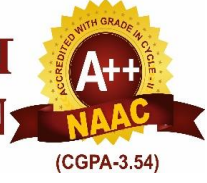
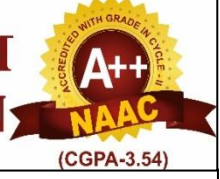

EXPRESSION OF INTEREST (EOI) FOR EMPANELMENT OF RETIRED JUDGES

Brief about University: The Central University of Rajasthan has been established by an Act of Parliament (The Central University Act, 2009) in March 2009. The University is fully funded by the Ministry of Education through University Grants Commission (UGC), New Delhi. It is located in the Jaipur-Ajmer Expressway and functions in 518+ Acres of lush green campus with all modern infrastructure & amenities. At present, the University is running significant and innovative 61 UG & PG Courses and PhD. Program through its 13 Schools and 35 Academic Departments. Further, 07 ODL programmes are also starting from the current academic year. There are more than 3400 students enrolled with the University out of which 2600+ students stay in the Hostels within the campus and a total 340+ employees (Teaching & Non-teaching) work in the campus.

Eligibility:

1. Retired Judges of the Supreme Court, High Courts, or District Judiciary, with a distinguished record of service, integrity, and unimpeachable judicial conduct.
2. Demonstrated experience in heading judicial, quasi-judicial, or fact finding commissions will be preferred without any criminal or disciplinary cases.
3. Age of the applicants should be below 75 years.

Experience:

Professional experience of District Judges or Justice in the Hon'ble High Court. Eligible applicants must provide experience documents to the University.

Scope of Work:

Empanelled Judges may be called upon to preside over committees constituted for

1. Conducting enquiries into specific complaints or issues requiring independent adjudication;
2. Heading internal or statutory committees for redressal, oversight, or compliance;
3. Rendering reasoned reports or recommendations within a stipulated time frame.



Honorarium:

1. Fixed honorarium will be paid as per enquiry basis, in accordance with applicable norms of the Government/Institution which will be commensurate with the nature and scope of the assignment.
2. Conveyance, travel charges will be paid as per norms of University level.
3. Administrative assistance will be provided by the University.

How to Apply/Application Process:

Eligible and interested candidates may submit their detailed curriculum vitae, along with a covering letter and retirement order such as Pension Payment Order (PPO) with service details expressing interest, to Registrar through email (email id – registrar@curaj.ac.in) as well as in the hard copy, to be sent to the following address:

The last date of receiving Applications in the prescribed format along with supporting document is 12.08.2025 till 2.00 PM hours.

Application for empanelment at CURAJ does not confer any right/ assurance whatsoever; to an applicant that he / she will be empanelled on the panel of CURAJ. Letters to retired Judges confirming their empanelment will be issued by CURAJ separately.

Tenure of Empanelment:-

The initial empanelment will be for a period of **two years**. However, on completion of the term and satisfactory performance of the Retired Judges, the empanelment may be extended by the CURAJ as per the terms & conditions in effect at the time of renewal. The CURAJ reserves the right to terminate the empanelment of any Retired Judge at any time without assigning any reason thereof.

Removal from panel:

CURAJ reserves the right to terminate the empanelment of a Retired Judge with one month's notice in writing without assigning any reason. The Retired Judge may also withdraw from the empanelment of Organization by serving one month's notice and the decision of the University in this regard shall be final & binding.
