Admission 2021-22 Guidelines (UG-PG-Integrated-Diploma)

Frequently Asked Questions (FAQs)

1. **Ques**: How to Apply?

Ans: For details, visit the university website https://www.curaj.ac.in/Admissions. The student has to register the portal using the CUCET-2021 Application ID and DoB.

- 2. **Ques**: Is a candidate required to be present in person for admission? **Ans**: No, the applicant must apply through online mode only.
- 3. **Ques**: What is the participation fee for the Admission-Counseling process?

Ans: All candidates will be required to pay a Non-Refundable Fee of Rs. 1000/- plus transaction charges and taxes as applicable to participate in the Admission-Counseling process.

4. **Ques**: What are the documents required for taking online admission?

Ans: Visit the university website and Refer point no (2) of 'CURAJ Admission 2021 Guidelines (UG-PG-Integrated-Diploma)'.

5. **Ques**: What are the eligibility requirements for admission?

Ans: For detail, visit the university website https://www.curaj.ac.in and refer to 'Academic Courses offered in A.Y. 2021-22'.

6. Ques: Will there be any disadvantage for gap year candidates?

Ans: No, there won't be any disadvantage for gap.

7. **Ques**: Can I write the percentage in place of CGPA or vice versa?

Ans: Yes, if any conversion formula from CGPA to the percentage or vice versa is given in the qualifying examination document.

8. **Ques**: How many preferences for a programme I can fill online?

Ans: Maximum THREE preferences of program, for which you are qualified in CUCET-2021.

9. **Ques**: Can the candidate modify the preferences of choices after submitting the online form?

Ans: NO. After submitting preferences online, the candidate cannot modify her/his choices.

10. **Ques**: I have provided incorrect information while filling up the online registration form and also paid the online registration fees. What shall I do?

Ans: After Online Registration/Fee Payment/Filling online Preferences, no modifications in any manner are allowed in the online admission portal.

11. Ques: I have several mark sheets of qualifying examination, how should I upload them?

Ans: Mark sheets of qualifying examination have to be uploaded together as a single (PDF/image) file with file size upto 10MB.

12. **Ques**: I am a final year student and have not received documents of qualifying examination and other documents at the time of admission, can I apply?

Ans: Yes. But you need to upload an undertaking in place of the requisite document. Refer to Annexure'B' of 'CURAJ Admission 2021 Guidelines (UG-PG-Integrated-Diploma)' in this regard.

13. **Ques**: I don't have an EWS / OBC-NCL certificate (issued on or after April 1, 2021), but I possess the older one, can I apply under EWS / OBC-NCL category?

Ans: Yes. Any such certificate issued earlier in this regard is acceptable along with an undertaking (Refer to Annexure 'B' of 'CURAJ Admission 2021 Guidelines (UG-PG-Integrated-Diploma)' available on the university website).

14. **Ques**: I have a photocopy of my documents. Can I Upload this for verification?

Ans: Candidates are required to upload all documents (coloured scanned copy of original documents) as specified in **point no (2)** of 'CURAJ Admission 2021 Guidelines (UG-PG-Integrated-Diploma)'. However, if the candidate does not have the originals with him/her, s(he) may upload the self-attested photocopies with an undertaking/assurance (Annexure 'B') of submitting original documents within the time frame as decided by the University.

15. **Ques**: What is the last date of accepting documents by the University?

Ans: Documents related to reservation are mandatory to submit at the time of registration. The last date of accepting relevant document of qualifying examination is **31.12.2021**. For submission of other documents, the last date will be **31.01.2022**.

16. **Ques:** If I am allotted a seat, but I do not want that seat and withdrew it, can I participate further in the open further round?

Ans: No. Once a seat is allotted and if you withdrew it, the candidate loses claim on his/her further participation in any subsequent round.

- 17. **Ques**: If I am allotted a seat which was my higher preference, can I participate in further rounds? **Ans**: If a candidate accepts such offer for higher preference of programme than his/her candidature shall not be considered for any other admission of lower preferences of programme in future. However, if a candidate accepts admission offer for lower preference of programme than his/her candidature shall open to consider for any higher preferences of programme in further rounds.
- 18. **Ques**: What if I decide to withdraw admission later? What are the refund rules?

Ans: Refund will be as per the UGC and the University guidelines. Refer to 'point no 6. 'Withdrawal and Refund Policy' of 'CURAJ Admission 2021 Guidelines (UG-PG-Integrated-Diploma)'.

19. **Ques**: How can I proceed with Hostel Admission, once my seat is confirmed?

Ans: After confirmation of admission, the student can apply online for a hostel facility. However, the application does not guarantee the availability/allotment of the hostel accommodation.

20. **Ques:** Who can issue the Medical Fitness Certificate?

Ans: Any MBBS graduate/equivalent who is a registered Medical Practitioner can issue the Medical Fitness Certificate? Please use the format in Annexure–C.
